FORKLIFT OPERATOR REFRESHER TRAINING

This Competency Unit specifies the skills and knowledge required by people to operate in the trade pertaining to operate forklift in the manufacturing / logistics industry in a WSQ Level 1 operation.

Target Audience

This course aims to provide people already working or wishing to enter the generic manufacturing industry with the skills and knowledge required to operate forklift. The Competency unit would be appropriate for people with job titles such as Forklift driver.
